Homeschool ALUMNI (“HSA”) 2007 Prince Edward Island Tour (“event”) Terms and Conditions, Assumption of Risk, and Release of Liability

Assumption of Risks. I understand that my participation in this Event will expose me to activities that range from mild to strenuous and include risks and dangers, foreseen and unforeseen, which can cause sprains, breaks, cuts, bruises, emotional trauma, illnesses, property damage, and the remote possibility of serious injury or death (“injuries and damages”). I acknowledge and fully assume all risks of such Injuries and Damages of attendance at this (“event”) whether or not described herein or in the materials provided to me.

Agreements of Release and Indemnity. I release, indemnify, hold harmless and otherwise agree not to bring or participate in any cause of action against HSA, its committee members, staff, agents, volunteers, or any related parties (“event staff”) for liability or claims of any nature, including Injuries or Damages, suffered by me or in any way related to my attendance, participation, or intent to participate in the event or its activities even if due to negligence from HSA staff or negligence of my own. I agree to indemnify HSA and event staff (that is defend them, including satisfaction of liabilities, costs and attorney’s fees) from claims brought by any other person arising out of my attendance and participation in the event and in its activities. I understand that HSA does not furnish accident, illness or medical insurance. In case of emergency, I authorize and accept all responsibility (including financial) for such medical procedures as are deemed necessary by event staff and I release HSA and event staff of any liability from injuries and damages suffered by me due to such medical determinations or procedures.

Use of Visual Images. I grant permission for HSA to make and use visual images (photographs, video) of me for display on the HSA website, in marketing materials, promotional videos, and other media.

Controlled Substances. During the event I will not bring, consume, or otherwise possess alcohol, tobacco or illegal drugs.

Prohibited Items. I will not bring to or possess any of the following items at the event: firearms, fireworks, explosive or projectile devices of any kind, straight-blade/non-folding knives, any weapon, inappropriate material, or item(s) listed as prohibited at <http://www.homeschoolalumni.org/content/packing> or otherwise determined to be prohibited by event staff.

Dress Code. During the event, I agree to comply with dress code requirements posted online at: http://www.homeschoolalumni.org/content/event_dress_code

I will conduct myself in accordance with a high moral standard and will not use profanity.

I will comply with the policies and instruction provided by event staff and the staff of the host facility. I agree to comply with any request to leave the event premises arising from my violation of the agreements contained herein, at the sole determination of, and/or at the request of event staff. The activities covered by these agreements include event related activities on or off the event premises, including transportation to and from the event if coordinated by HSA.

This Agreement is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.

This agreement supersedes any prior understanding, whether in writing or verbal, with respect to the subject matter hereof.
